HIGH SCHOOL STUCO REPORT

Dr. Bowman shared he continues to enjoy serving the Greater Woodland Park Chamber of Commerce Board and they are engaged in their annual strategic planning and reconfirms the commitment they have toward pursuit of the prosperity of businesses in Teller County.

Dr. Bowman shared school safety is a priority and due to the tragedy today in Florida there will be increased police presence.

Vice President Gwynne Dawdy distributed a draft memo that will go out to all staff tomorrow and if board members had any questions or suggestions to let her know and she will send to Kelley Havin for her to send out in the morning to all staff; Ms. Dawdy also distributed draft interview questions for the superintendent interviews and shared there were several very similar questions that she deleted and replaced with different questions and asked the other board members to review and any comments, changes, etc. need to be sent to Board President Beth Huber. Director Nancy Lecky shared that she and Ms. Dawdy met with Middle School Principal Yvonne Goings to visit the Summit Learning program in action. The concern was will this be a fit for all kids with the expansion plan of this program beginning for 2018-19 school year. They both were extremely impressed with this program and communication about this program to all parents will be the key for this to be a smooth transition.
