PUBLIC RELATIONS UPDATE

Public Relations/Communications/Grant Writing Specialist Stacy Schubloom shared details for the Homecoming Parade and thanked the Board of Education for their participation; Media Relations – sent the following information to the local papers on: Elementary Fun Runs; Walk to School Day; WPMS Color Run; WPHS Senior Shane Saylor receiving an academic award from the National Academy


